Special East Kingdom Announcement regarding the Pikestaff

The SCA Board policy on kingdom electronic newsletters (e-newsletters) is scheduled to take effect on January 1, 2012, with the first e-newsletter available being the March, 2012 issue. Here are some of the important details of this policy:

• All paid Sustaining and International members will have access to all SCA, Inc. kingdom e-newsletters via a password-protected website, even if they choose to continue receiving paper newsletters.

• All kingdom newsletters will be 8.5" x 11" with a uniform page count to allow all the paper newsletters to be sent in one bulk mailing.

• Within each kingdom, the paper and electronic newsletters will contain the same information, but the kingdom will have the option of including a supplemental PDF of articles, photo essays, art, etc. for the newsletters website.

- Once the link to the e-newsletter website is available on www.sca.org (after January 1, 2012), you may discontinue your paper newsletter, no matter where you are in your membership cycle. However, please be aware that no refunds can be issued if you choose to do so.
- An e-newsletter will not constitute proof of membership. For further info you can check <u>www.sca.org</u> or write to <u>comments@sca.org</u> and we will try to answer any question you may have.

From the West: Take the Long Island Expwy. to Exit 64 north (NY-112 towards Port Jefferson). Drive for 3.2 miles, then turn right onto Middle Country Rd. (Rt. 25) for .03 miles and jog left onto Mt. Sinai Coram Rd. for 2.2 miles. Turn right onto Whiskey Rd. for 1 mile. Then turn right onto Middle Island Blvd. The entrance to Estonian House will be on your right.

From the East: Take the Long Island Expwy. to Exit 68 north (William Floyd Pkwy. CR 46) to Middle Country Rd. Rt. 25. Make a left and travel on Rt. 25 for 4.7 miles. Turn right onto Church Lane, then take your third right onto Lake Terrace. Turn left onto Middle Island Blvd. The entrance to Estonian House will be on your left.

For those interested in the history of England between 1216-1272, King's College London has been involved in a project to digitize the **Fine Rolls of Henry III**. They can be found at : <u>http://www.frh3.org.uk/index.html</u> In case you're wondering, the Fine Rolls record offers of money to the King of England in return for concessions and favors. They are among the early primary sources for determining the relationship between the King and his people. While the Rolls may record the *intention* of the parties, the money often didn't actually change hands, so the Rolls are always read in the context of their history to help us gain insight into these emerging governmental structures.

Archaeologists have unearthed an apparently intact **Viking burial site** on the west coast of Scotland. Said to be the first intact pagan Norse grave excavated in over thirty years, the grave goods include the remains of the boat he was buried in along with his sword, shield, drinking horn and knife. While we're on the subject of neat burial finds, an exhibition of objects from the **Staffordshire Hoard** has opened in Washington, D.C. at the **National Geographic Museum** and will run until March 4, 2012. Among other Renaissance glories currently on exhibit, **The National Gallery** in Washington, D.C. will be hosting the **Pastrana Tapestries** until January 8, 2012. Among the finest surviving Gothic tapestries, these were created to commemorate the Moroccan military victories of King Alfonso V (1432-1481). This is the first time the four tapestries have been viewable together in the United States. Enter 'museum passes' in the search field to find out if your library offers passes. Here's a partial list of some current exhibits and activities of interest:

The Morgan Library and Museum at Madison Avenue and 36th St. continues to host *Treasures of Islamic Manuscript Painting* through January 29, 2012. Along with a rare opportunity to see several of the works unbound, the Morgan is also featuring a number of related programs to illuminate the exhibit. On Friday, November 18 at 7 p.m., there will be a Gallery Talk entitled "Treasures of Islamic Manuscript Painting from the Morgan". For a full listing of the related programs, please see the museum website: <u>http://www.themorgan.org/exhibitions/exhibition.asp?id=50</u>. Remember, admission to the Morgan is FREE on Friday evenings from 7:00 p.m. to 9:00 p.m.

The Metropolitan Museum of Art at Fifth Avenue and 82nd Street is always a delightful place to view historic art and sculpture. The museum has several current exhibits that might be of interest to the membership. Just opened: the new exhibition, <u>Art in Renaissance Venice, 1400–1515: Paintings and Drawings from the Museum's Collections</u>, through February 5, 2012. The museum continues to host <u>Wonder of the Age: Master Painters of India, 1100-1900</u> through January 8, 2012. In addition to the exhibitions, there are several companion events. Check the main web page for complete information. Other continuing exhibitions include <u>Historic Images of the Greek Bronze Age: The Reproductions of E. Gilliéron & Son</u>, through June 17, 2012, which focuses on the artwork discovered at the excavations of Troy and Knossos in the 19th century. Up at **The Cloisters** at 190th Street in Fort Tryon Park, garden tours and museum highlight tours are given regularly. This represents the first time such a large ensemble of the chessmen has traveled outside the United Kingdom.
