Why Your Vote Is Important

Here we are in the midst of the baronial polling process! Thanks to all of you who have already returned your GREEN ballots. If you are a paid member of the SCA and live within the confines of the Barony of An Dubhaigeainn, and have not yet received your GREEN ballot, **please contact the Coronet by e-mail at ateno@panix.com or the Deputy Seneschal by e-mail at mdavies1@optonline.net immediately with your name, ZIP Code and membership number.**

In order to hold a valid poll, there are a number of East Kingdom rules that must be strictly observed. One of the most important rules is that, "At least one-half (50%) of the polled members must respond to the polling for a polling to be considered valid." That means that in order for us to have a valid poll, at least 50% of the ballots mailed out must be returned AND must be valid. **We therefore ask you in the strongest possible terms to fill out your ballot properly and return it in plenty of time to be counted.** *Remember, children's ballots count towards our necessary minimum so make sure to submit valid GREEN ballots for your kids!*

Who can vote: To cast a valid vote, you must live within the Barony AND be a current paid member of the SCA. **Please check your membership card to verify that your membership is current.** If your membership has expired or is about to expire, please renew ONLINE so that the East Kingdom has the most up to date roster of our paid membership. We do not prepare the mailing list, so the best way to insure that you receive your ballot is to make certain your membership is current. If you renew by mail, you run the risk that the paperwork will not be updated in time to include you on the polling mailing list. ALL valid ballots returned will count towards the required 50% return rate, but only those valid ballots cast by members at or above the age of 14 will count towards the poll results. To insure that the Barony exceeds the required 50% return rate, it is very important that our members under the age of 14 submit valid GREEN ballots.

How to cast a valid ballot: In order to cast a valid ballot, you must:

1. Choose one candidate OR set of candidates OR abstain, and mark the appropriate box. (Members under 14 should not check any of the candidate or abstention boxes.)
2. Check one box to indicate your age - over or under 14.
3. Sign your legal (modern) name on the noted line.
4. Add your SCA membership information in the appropriate space.
5. Seal and return the GREEN ballot in the supplied envelope well before the due date printed on the ballot. **Since ballots must be received by the East Kingdom on or before the due date (April 16, 2012) to be valid, please mail them with plenty of time to spare.** Your ballot should be postmarked **no later than April 9, 2012.** Ballots mailed on or near the due date will likely not be received in time and will be invalid, which means they will not be counted towards either the minimum number of ballots required for a valid polling, or towards your preference for the next Coronet.

If you have any questions regarding any part of the process, please contact the Seneschal, the Deputy Seneschal or either of the current Coronets. If you wish to learn more about the process, you can read it in the current version of the Laws of the East Kingdom at: <http://seneschal.eastkingdom.org/docs/EKLaw.pdf>. Click on Section VII. C. on page 16 and scroll down to subsection 3, "Ballots and the Polling Process". Please note that because our polling falls close to recently effective changes to East Kingdom law, we are bound by the rules in effect as of the November, 2011 Curia.

We will send out one last weekly reminder to validate and return your ballots as soon as possible to insure that we have a valid poll. Thank you for your participation and support.

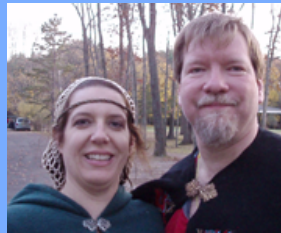
Meet the Candidates

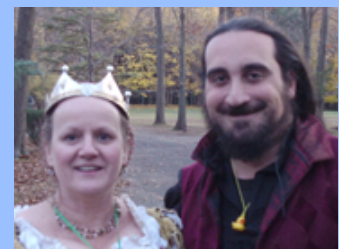

Weasel's watchwords are *Strong and Just*. A long time member of both the Barony and House Three Skulls, Weasel hopes to inspire people to be their best. As he likes to say, he hopes to "utilize people, not use them." He's been in the SCA for over 21 years and believes that by encouraging close ties between new and old, it will help to open up discussions with original energy and ideas. He sees training new recruits as an important part of a Baron's job, and hopes to strengthen ties among the various households by "fostering fighting team relationships". He believes a Baron must remain neutral when conflict arises, first ascertaining whether it's a real conflict or just a miscommunication. Damianna has been playing for slightly less, but each of them stresses their shared experience wearing several managerial hats, whether for their mundane jobs or as former officers of the Barony. To avoid a perception of favoritism, they favor open communication and might employ a neutral party to facilitate discussion. Should problems arise between the EK and the Barony, they favor face to face meetings with officers and royalty informally outside of the SCA to resolve conflict.
