Why Your Vote Is Important

The Baronial polling process for the selection of the next Coronet starts February 28, 2012. If you are a paid member of the SCA and live within the confines of the Barony of An Dubhaigeainn, you should receive a ballot near the end of February. The mailing will include your ballot as well as a stamped, pre-addressed return envelope.

In order to hold a valid poll, there are a number of East Kingdom rules that must be strictly observed. One of the most important rules is that, "At least one-half (50%) of the polled members must respond to the polling for a polling to be considered valid." That means that in order for us to have a valid election, at least 50% of the ballots mailed out must be returned. We therefore ask you in the strongest possible terms to fill out your ballot and return it in plenty of time to be counted.

Who can vote: To cast a valid vote, you must live within the Barony AND be a paid member of the SCA. **Please check your membership card to verify that your membership is current.** If your membership has expired or is about to expire, please renew ONLINE so that the East Kingdom has the most up to date roster of our paid membership. We do not prepare the mailing list, so the best way to insure that you receive your ballot is to make certain your membership is current. If you renew by mail, you run the risk that the paperwork will not be updated in time to include you on the polling mailing list.

ALL valid ballots returned will count towards the required 50% return rate, but only those ballots cast by members at or above the age of 14 will count towards the election results. Because of this, it is still important that our members under the age of 14 submit a valid ballot.

In order to complete a valid ballot, you must:

1. Choose one candidate or set of candidates OR abstain, and mark the appropriate box.
2. Check one box to indicate your age - over or under 14.
3. Sign your legal name on the noted line.
4. Add your SCA membership information in the appropriate space.
5. Seal and return it in the supplied envelope well before the closing date printed on the ballot. **Since the ballots must be received by the due date, please remember to mail them with plenty of time to spare.** If you mail your ballot on or near the due date, it is likely that it will not be received in time. Remember, any ballot received after the due date will not be counted towards either the minimum number of ballots required for a valid polling, or towards your final choice of Coronet.

If you do not receive your ballot, blank ballots will be available at the Baronial business meetings held on the first Thursdays of March and April. Please bring proof of address and proof of SCA membership and talk to the Seneschal, Sean de Londres.

If you have any questions regarding any part of the process, you may talk to the Seneschal or either of the current Baronial Coronets. If you wish to learn more of the process or read the East Kingdom's original document, it is at: <http://seneschal.eastkingdom.org/docs/EKLAW.pdf>. Move down to page 16 and start at '3. Ballots and the Polling Process'. Please note that because our polling falls close to the effective changes to East Kingdom policy, we are bound by the rules in effect as of the November Curia.

Once the ballots have been mailed, we will send out weekly reminders to validate and return your ballots as soon as possible to insure that we have a valid poll. Thank you for your participation and support.

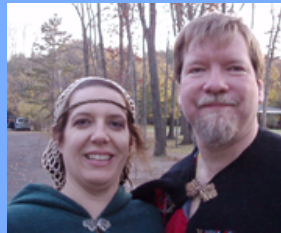
Meet the Candidates

Damianna has been playing for slightly less, but each of them stresses their shared experience wearing several managerial hats, whether for their mundane jobs or as former officers of the Barony. To avoid a perception of favoritism, they favor open communication and might employ a neutral party to facilitate discussion. Should problems arise between the EK and the Barony, they favor face to face meetings with officers and royalty informally outside of the SCA to resolve conflict.
