## East Kingdom: Important News about Membership and Newsletters

Starting March 1, 2012, Sustaining and International members will have access to the Kingdom enewsletter website. Paper newsletters are still available, for an additional fee, when you purchase or renew membership.

Current members can choose to stop receiving paper copies of the newsletter and use online access only by filling out the <u>Opt Out form</u>.

Please read the <u>FAQ</u> for more details on these changes.

# Why Your Vote 1s Important

The Baronial polling process has begun. If you are a paid member of the SCA and live within the confines of the Barony of An Dubhaigeainn, you should receive a ballot to state your preference for the next Coronet within the next few days. The mailing will include your ballot as well as a stamped, pre-addressed return envelope. <u>If you do not receive your ballot by March 16</u>, please contact the Seneschal with your name, ZIP code and membership number at (631) 775-7083 before 10:00 p.m. or by e-mail to <u>bndelondsen@aol.com</u>.

In order to hold a valid poll, there are a number of East Kingdom rules that must be <u>strictly</u> observed. One of the most important rules is that, "At least one-half (50%) of the polled members must respond to the polling for a polling to be considered valid." That means that in order for us to have a valid poll, at least 50% of the ballots mailed out must be returned AND must be valid. We therefore ask you in the strongest possible terms to fill out your ballot properly and return it in plenty of time to be counted.

<u>Who can vote</u>: To cast a valid vote, you must live within the Barony AND be a paid member of the SCA. Please check your membership card to verify that your membership is current. If your membership has expired or is about to expire, please renew ONLINE so that the East Kingdom has the most up to date roster of our paid membership. We do not prepare the mailing list, so the best way to insure that you receive your ballot is to make certain your membership is current. If you renew by mail, you run the risk that the paperwork will not be updated in time to include you on the polling mailing list.

ALL valid ballots returned will count towards the required 50% return rate, but only those valid ballots cast by members at or above the age of 14 will count towards the election results. To insure that the Barony exceeds the required 50% return rate, it is very important that our members under the age of 14 submit valid ballots.

#### How to cast a valid ballot: In order to cast a valid ballot, you must:

1. <u>Choose</u> one candidate OR set of candidates OR abstain, and <u>mark the appropriate box</u>. (Members under 14 should not check any of the candidate or abstention boxes.)

- 2. <u>Check one box to indicate your age</u> over or under 14.
- 3. Sign your legal (modern) name on the noted line.
- 4. <u>Add your SCA membership information</u> in the appropriate space.

5. <u>Seal and return the ballot in the supplied envelope</u> well before the due date printed on the ballot. Since ballots must be <u>received</u> by the East Kingdom on or before the due date (April 16, 2012) to be valid, please mail them with plenty of time to spare. Your ballot should be postmarked no later than April 9, 2012. Ballots mailed on or near the due date will likely not be received in time and will be invalid, which means they will not be counted towards either the minimum number of ballots required for a valid polling, or towards your preference for the next Coronet.

If you do not receive your ballot in the mail, blank ballots will be available at the April Baronial business meeting. Please bring proof of address and proof of SCA membership and talk to the Seneschal, Sean de Londres.

If you have any questions regarding any part of the process, please contact the Seneschal or either of the current Coronets. If you wish to learn more about the process, you can read it in the current version of the Laws of the East Kingdom at: <u>http://seneschal.eastkingdom.org/docs/EKLAW.pdf.</u> Click on Section VII. C. on page 16 and scroll down to subsection 3, "Ballots and the Polling Process". Please note that because our polling falls close to recently effective changes to East Kingdom law, we are bound by the rules in effect as of the November, 2011 Curia.

Once the ballots have been mailed, we will send out weekly reminders to validate and return your ballots as soon as possible to insure that we have a valid poll. Thank you for your participation and support.


# Meet the Candidates


Lord Methias Tiberius Weasel (Ronald W. Sadler II) can be reached by phone at (631) 395-3330 before 10 p.m.

Weasel's watchwords are Strong and Just. A long time member of both the Barony and House Three Skulls, Weasel hopes to inspire people to be their best. As he likes to say, he hopes to "utilize people, not use them." He's been in the SCA for over 21 years and believes that by encouraging close ties between new and old, it will help to open up discussions with original energy and ideas. He sees training new recruits as an important part of a Baron's job, and hopes to strengthen ties among the various households by "fostering fighting team relationships". Damianna has been playing for slightly less, but each of them stresses their shared experience wearing several managerial hats, whether for their mundane jobs or as former officers of the Barony. To avoid a perception of favoritism, they favor open communication and might employ a neutral party to facilitate discussion. Should problems arise between the EK and the Barony, they favor face to face meetings with officers and royalty informally outside of the SCA to resolve conflict.
