#### **Directions:**

Long Island Estonian House is located 65 miles east of NYC in Middle Island, New York, north of NY Route 25.

From the West: Take your best route to the Long Island Expwy (I-495) east, to Exit 64 North (NY-112) towards Port Jefferson. Drive for 3.2 miles, then turn right onto Middle Country Rd. (NY Rt. 25) for .03 miles and jog left onto Mt. Sinai Coram Rd. for 2.2 miles. Turn right onto Whiskey Rd. for 1 mile. Then turn right onto Middle Island Blvd. The entrance to Estonian House will be on your right.

From the East: Take the Long Island Expwy. to Exit 68 North (William Floyd Pkwy.-- CR 46) to Middle Country Rd. (NY Rt. 25). Turn left and travel on NY Rt. 25 for 4.7 miles. Turn right onto Church Lane, then take your third right onto Lake Terrace. Turn left onto Middle Island Blvd. The entrance to Estonian House will be on your left.

## Activities at the Baronial Investiture!!!!

November 10th

#### A most devious Fencing Tournament is being planned.

The first part "Are you being Served" will comprise of 2 fencers vying for the opportunity to serve a drink to their new Baroness. Each fencer will be allowed a single rapier, and have to balance a mug/goblet, chosen at random, on a buckler. Bucklers will be available for loan for those who do not own one. When the order to "serve" is announced, each fencer must try to stop the other fencer by doing one of the following (in this priority): a wound to either arm (you cannot defend yourself or you spill the drink), a kill shot, or knock the drink off the opponent's buckler. If the drink is spilled for any reason, likewise, that fencer is out. Leg wounds do not count and are ignored. In case of a close tie the first drink spilled will be the deciding factor, as voted by other fencers. Each fencer will do combat with their opponents 3 times to get a cumulative score, and there are prizes for the top 8 scores.

After the pleasantries are over and all fencers are justifiably upset about their performance, we will devolve into the next tourney, "The Vulgar Brawl." For the purpose of this event, all fencers are considered qualified in Soft Parry use. When "The Baroness has left the building!" is sounded, the mayhem begins! There will be 2 doors to enter the Bar, and there will be 2 tables available with various "weapons" that any fencer can Claim while in the Bar. You may exchange your off hand item at any time for any Qualified Weapon so long as you are alive. Each Fencer will be allowed only a single Rapier to enter the Bar, and if you wish to use any other special weapon, it must be placed on the Tables prior to the start of this tourney. Of course, any fencer may decide to claim it for themselves prior to you getting into the Brawl! The top 3 fencers in the prior phase will be in the Bar, and it is a "every fencer for himself/herself" scenario, with special rules of Death from Behind, No Quarter, No Honor, Autospawn, and Grab it and Go. Once dead, you MUST surrender your offhand weapon to the Table OR return a soft parry item on the floor to any table, NO EXCEPTIONS. Double kills count as both fencers Dead. Dead fencers must exit to the MOL, register, and reenter at either Door. If all fencers agree (and I hope so) Soft parry items that we provide can be thrown at any opponent. RBG's ARE allowed but once used, become a rigid parry device and cannot be reloaded again.

Autospawn: there will be a bell sounded every 30 seconds, signaling the next fencers to enter the Bar, one from each Door. You will respawn with a single Rapier only.

Grab it and GO: Each fencer can use ANY item on a Table, or pick up a soft parry item from the Bar floor. You can exchange your off hand item at any time, and throw the soft items whenever at whomever in the Bar. You cannot stash any weapon/item in your belt or on your person.

Death from Behind: as per melee rules.

No Honor: Any soft alliance can be made and broken at any time, and you are encouraged to be sneaky and underhanded, as well as grab any item off the Tables, even if not your own (fencers have to plan what to leave on the tables accordingly).

No Quarter: If no hold is called, do whatever is necessary to stay alive. Do whatever is needed to kill your opponents. (within SCA rules).

Honorable Behavior is the fastest pathway to getting killed. Your score will be how many times you are killed, not how many wounds you deliver. The winner will be announced as the most Devilishly Clever Fencer in Court.

Previously, at our Potted Arms Event "This year's winner and new Baronial Thrown Weapons Champion is Lord Magnus Sverre Haakson. Since Lord Magnus could not stay for court, and therefore was not invested with his ceremonial regalia, Baroness Lassar took charge of it, and has contemplated an appropriate quest for Magnus as a Penance for a Champion Who has Missed Court. At Arrows and Ales Lord Magnus finally Received his Regalia, and will be Serving his Penance by Serving at High Table for Investiture in November. This announcement was well received by all, though rather Sheepishly by Lord Magnus.

Coming up in November is the Baronial Heavy List Championship, which will take place at Investiture (see pages 4-5) Good luck to all contestants. Please be reminded that one need not be able to Serve as Champion in order to Compete. The more fighters involved the more fun it is. If you are close to Qualifying in a New Weapon, or close to Achieving your Original Qualification as a Fighter (or a Fencer) you will have the opportunity to get your Qualification before the Tourney starts. You may remember reading of a Fighter who qualified last year at this event and went on to Best a Knight in his first Tourney. (It has happened before, it can happen again)

## Coming Soon!!! Arts and Sciences Championship!!!

Although the date is not yet official, our Baronial Arts and Sciences Schola and Championship is only a few months away. Since it is normally held in late winter/early spring, our current Champion, Rue, has so graciously decided to post the rules for this year's competition early to give participants an adequate amount of time to complete their projects.

This year, each participant is required to create **three** different pieces, each representing a different A&S medium (sewing, painting, calligraphy, music, woodworking, etc.)

In addition, the three pieces must have a common theme. For example, one could embroider a rose for one piece, create an illumination including roses, and write a rose-inspired periodstyle song. Another example would be to carve a wooden bowl

with a fish design, then have fish similarly decorate a leather pouch, along with a serving of fish.


## From the Coronet
