

Outline of the changes in the Baronial Policy September 2020 Draft from the July 2008 Baronial Policy

Major Changes:

- 1) Definitions of Terms (I.C.)
 - a) Terms and definitions removed from this section of this policy due to being obsolete or redundant.
 - b) Terms and definitions added to bring the policies up to date.
 - c) Terms and definitions moved to a more logical location within the policy.

- 2) Baronial Officers (II.B. and II.C.)
 - a) Listing the Greater Officers and Lesser Officers while using the EK Officer list as a guide.
 - b) Adding the Greater Office of Webminster and the Lesser Office of Social Media Officer to bring the list of Officers up to date.
 - c) Making the Deputy positions of Deputy Knight Marshal, Captain of Archers, Marshal of Rapier, and Marshal of Thrown Weapons into Lesser Officer positions.
 - d) Clarification of individual duties.

- 3) Selection and Replacement of Baronial Officers (II.D.)
 - a) Rewritten for clarity.

- 4) Terms of Office and Officer Removal (II. E.)
 - a) Rewritten for clarity.

- 5) Baronial Events (III)
 - a) Rewritten and reorganized for clarity.

- 6) Fiscal Procedures (IV.)
 - a) Rewritten and updated to follow East Kingdom Exchequer Policy.
 - b) Financial Committee (IV. A.) added stating those who are in the committee and their responsibilities.

 - a) This was added if extraordinary circumstances lead to an extended period of inactivity within the SCA and/or the East Kingdom.

Minor Changes:

- 1) Policy rewritten to be gender neutral.
- 2) Duties and Powers of the Baronial Officers (II. A.)
 - a) Listing the basic duties and responsibilities of all Officers with clarity.
- 3) Baronial Events (III C.)
 - a) Removed Autocrat meetings
- 4) Baronial Events (III C. and III D.)
 - a) Replaced the term Autocrat with Event Stewart to bring the position's title up to date.
- 5) The Event Stewart's Responsibilities (III E.)
 - a) Rewritten for clarity and to update responsibilities.
- 6) Baronial Chartered Organizations (V.)
 - a) Rewritten using East Kingdom Law regarding Guilds as a guideline.
- 7) Policies of the Barony of An Dubhaigeainn (VI)
 - a) Removed the initial approval of Baronial policies that occurred when An Dubhaigeainn became a Barony.
 - b) Storage (VI A.)
 - i) Added that the Baronial website will host a current copy of the Baronial Policy.
 - c) Amendment (VI C. 2. c. i.)
 - i) Announcement of a Baronial Curia 60 days prior to the Baronial Curia was changed to 45 Days prior.
- 8) Awards (VII)
 - a) All Baronial awards are listed and current as of August 31, 2020.
