Port Jefferson-Patchogue Rd (112) turn east off of 112 on to Granny Rd. Follow Granny. It will make a Very sharp left turn. At this turn the road becomes Ashton Rd. Follow Ashton Rd 150 FEET before a stop sign look to your left for wood railroad ties that's Sylvia Lane. Turn on to Sylvia Lane. We are the first house on the right.
